Sub: Issuance of Essentiality Certificate Under Rule 44 of Delhi Education Rules 1973, from Ist to VIIIth Standard (Vaild upto 31/10/2009)

Sir,

This is with reference to your application dated 23/04/03 to establish a new school under Rule 44 of D.S.E.A & Rules 1973, I am directed to state that the appropriate authority after considering the particulars specified in the application form has accepted the proposal to establish a new school from class Ist to VIII in Zone No. XII of Distt. North West (B).

1. The said acceptance to establish new school in Zone XII of Distt. N.W (B) shall be limited only for a period of 05 (five) years. Please noted that no extension to this limit of 05 (five) years would be granted under any circumstances.
2. The acceptance to establish new school will automatically lapse, if the Society/ Trust fails to obtain recognition from the appropriate authority after fulfilling the conditions of recognition as laid down in Rules 50 & 51 of D.S.E.A & Rules, 1973 and Sub-Section (1) of section 4 of D.S.E.A & rules, 1973 within a period of 5 years.
3. Standard preliminary for recognition of the school are enclosed for favour of your appraisal and guidance.
4. This is issued subject to the condition that the school will follow the directions of department on fee structure etc.
5. As indicated by you in your EC application, you would not be requesting for sponsorship of land at any stage.
6. The Society will not establish the proposed middle school on the land measuring 2 acres bearing khesra No. 25/2(4-16) and 25/3(4-16), situated in the Revenue Estate of Village Mohammedpur Majri, Delhi Colony known as Rama Vihar Delhi because the society had earlier submitted land documents for the above land, which is for agricultre purpose.
