- 7. That the Management of the school shall create a reserve fund in the form of Fixed Deposit in the joint account in the name of Manager of the School and Dy. Director of Education (Distt.) equivalent to 3 months salary of staff or Rupees One lakh + Rs 80/- per student within 3 months from the date of issue of letter.
- 8. That in no case the school funds will be diverted/ transferred to any other fund/account of the society. The school funds will also not be utilized by the society for any other purpose other than that of the school.

- 17. In case of Provisinal Recognition to the school situated in Non-Confirming Area, the recognition will be subject to the outcome of notification by Ministry of Urban Development Govt. of India, Delhi.

18. That the violation of any instructions/order/rules and regulations of the

department, shall lead to the withdrawal of recognition of the school.

19. That the school shall submit the latest copy of water test report issued by Delhi Jal Board within 02 months submit the requisite documents to the District Authority.

20. That the school shall appoint the 2nd special educator within 02 months

and submit the requisite documents to the District Authority.

21.That with clause 14 of order the school shall comply F.DE/15(56)/ACT/2009/778 dated 11/02/2009 in r/o maintenance of DRF, School shall also ensure to follow FN-21 "Accounting by schools" as issued by the Institute of Charted Accountants of India (ICAI) for proper accounting treatment.
